
CA-1557/19 has been filed by the RP praying for exclusion of 53 days on account of pendency before the Hon'ble NCLAT in an appeal filed by the ex-Directors. A stay order was directed which remained in force for the period between 19.06.2019 to 26.07.2019 i.e. 37 days. Prior to the same, the order of




admission dated 27.05.2019 was communicated to the RP only on 13.06.2019 i.e. after 16 days. It was only after receipt of the communication that he could take steps and initiate the CIR process. He there seeks exclusion of 53 days in terms of the decision of the Hon'ble NCLAT in the matter of Quinn Logistics India Pvt. Ltd. Vs. Mack Soft Tech Pvt. Ltd. & Ors. (Insolvency) AT No. 185 of 2018. Keeping in view that the CIR period can be extended beyond the 180 days upon a resolution being passed by the CoC, This application for exclusion of days is not pressed for at this stage pray for one of the ex-Director.

CA-1506/19 has been filed invoking the provisions of Section 43, 45, 48, 49, 50, 66, 67 & 69 of the Code. Notice of this application be effected on the non-applicants returnable on 10th December, 2019. Dasti. It is submitted that two of the non-applicants have already filed their replies. To come up on 10th December, 2019.
